

HUMBERSIDE FIRE AUTHORITY – MEMBERS' ALLOWANCES 2020/21

The Local Authorities (Members' Allowances) (England) Regulations 2003 require the Authority as soon as is reasonably practicable after the end of each financial year to publish the allowances paid to each Member. Each Member of the Authority receives a Basic Allowance to recognise the time devoted to Fire Authority work. The Special Responsibility Allowances are payable to those Members who hold positions which require them to spend more time and effort on the Authority's affairs than would be expected of other Members. Travel and subsistence allowances are payments made to reimburse the Members for expenses incurred on Authority business.
